



49- Fees and FEEE Policy

Cornerstone Pre-school aims to provide affordable pre-school education to children aged between 2 and 5 years. Children are entitled to funding from London Borough of Waltham Forest Council for 15 hours per week for 38 weeks a year (570 hours per year) hours can be used flexibly and can be seen in the table below.

The Free Early Education Entitlement (FEEE) runs from the term following their 3rd birthday, or children receiving 2 year old funding from the term following of their 2nd birthday.

From September 2017 the Government introduced an additional 15 hours of extended entitlement for working families. This means that some 3 and 4 year olds will be entitled to 30 hours of FEEE. You can check if your child is eligible by visiting: www.childcare-support.tax.service.gov.uk and find out how to access tax-free childcare. Please note that we are not under any obligation by the Government to offer the additional 15 hours. From April 2024 the Government introduced additional 15 hours for 2 years olds for working families.

Pre-school currently runs for 39 weeks, this includes inset days during the year. The FEEE divided into 3 terms: Autumn, Spring and Summer. For further details of how the FEEE system operates speak to the Business Manager (Ruby Marwat)

Consumable fees

A cost for consumables, which includes snacks, paper, arts, and crafts material etc., which is a significant volume and spend each year. This amount is payable per morning or afternoon session, so for children attending core sessions there would be 5 consumable charges a week.

Please see table below for consumables charges. Please note, consumable fees are payable per session regardless of whether the session is funded by the government or paid directly. Deposits

Funded Children (2, 3 and 4 year olds):

If your child only attends Cornerstone Preschool for the funded hours allocated to them, no deposit will be required.

Non-Funded Children:

Cornerstone Pre-school will request 1 week's fees as a deposit which will be deducted the week the child leaves or will be returned to you once your child leaves and all fees are paid.

If during the year the parents wish to change the number of attended days, they will be asked to add the rest of the sum to the deposit to cover the full price of the deposit of 1 week's fees.

Emergency Closure

In unavoidable and exceptional circumstances, such as notifiable infection or consequential damage following a fire, it may be necessary to close all or part of the Preschool at short notice. In common with most preschools, it is not the preschool's policy to refund fees in such circumstances.

- 1) Cornerstone Pre-school will charge a non-refundable £20.00 registration fee to cover administration costs for FEEE/FEE.
- 2) Cornerstone Pre-school will charge £22.00 per session for 3&4 year olds which exceed the FEEE (15 hours per week) and £25.00 per session for 2 year olds.
- 3) Cornerstone Pre-school will charge consumable fees. See table.
- 4) Cornerstone Pre-school will request 1 week's fees as a deposit which will be deducted the week the child leaves.
- 5) Lunch club - children will need to bring in their own packed lunch, and the charge for the lunch ½ hour will be £5.00
- 6) Pre-school follows the term dates issued by London Borough of Waltham Forest Council.
- 7) Fees will be reviewed annually at the Annual General Meeting (AGM)
- 8) All fees are payable in advance **weekly/monthly/termly** and must be paid by the dates stated on the invoice and are non-refundable.
- 9) FEEE is paid directly to the Pre-school by the local authority.
- 10) Fees are still required if a child is absent. In cases of prolonged absence, parents should consult the Business Manager/committee about fee payment.



11) Should fees remain unpaid 2 weeks after the due date, the following action will be taken:

- A letter from the Business Manager requesting payment of outstanding fees within 4 working days will be sent/emailed to parents.
- Should fees remain unpaid, the child's place at Cornerstone Pre-school will be forfeited and only the sessions that are paid under the FEEE will be permitted until the outstanding amount is cleared. (Unfortunately, there will be no guarantee once the outstanding balance is cleared that the child will be able to resume extra sessions not paid under the FEEE)
- Should you wish to permanently withdraw your child from Cornerstone Pre-school, or reduce the number of sessions, the notice period is 28 days for a fee paying child and two weeks notice for a child that is in receipt of the FEEE from the local authority. Written notice must be given to the Business Manager or Pre-school Leader.
- Please see the Business Manager if there are any unforeseen circumstances you wish to discuss. We are a community group and are financed by FEEE, Church subsidy, and children's fees.
- Parents of children for the FEEE need not make any contribution to their child's fees except a £20 registration fee and 50p per session/day donation towards snacks and art/craft supplies.
